TAIWAN CARE CENTER

1. Background

Due to special political sitution, during the past forty years, there are countless people who have been arrested because of different political opinions, or unknown reasons, imprisoned with or without trial for 5,10,20, or 30 years. Some have died in prison.

Those persons and their families have been neglected, lonely, helpless, and hopeless under miserable conditions for long periods of time, and few people dare to give any support.

In 1979, the Kaohsiung incident occurred. 51 people sentenced to a total of more than 200 years in prison. This caused such a shock and enabled the Taiwanese people to think about matters of social justice and to be concerned about problems of human rights.

The next year the government permitted elections for additional seats in the National Assembly, legeslative yuan, and control yuan. At this time, every candiate from family members or defense lawyers of Kaohsiung incidents prisoners was elected to office in there bodies with a strong show of support. It shows obviously that the expansion for Social justice and commitment of people seeking for democracy and human rights.

In 1981, Yao, Chou Ching-yu, the wife of Yao Chia-wen who is the famous human right lawyer, but he got twelve years sentences because of the Kaohsiung incident. She set up the Taiwan Care Center immediately after being elected to the National Assembly.

Aided by many friends who are concerned about human rights, she started the project, surveyed many of the major human rights cases, and visited political prisoners, through social work method to bring warmth and dignity back to those suffering people. In addition to futher spread the concept of human rights and expand the content of care work, gather resources and publish the first Journal for human rights "Care Magazine" by then the Taiwan Care Center has taken on a special mission to promote human rights.
