I. LOCATING KEY LEADERS: PURPOSE, SCOPE, AND PROCEDURES

The largest single organized pool of volunteer leaders is in local associations of volunteer directors, or people in allied leadership roles. These associations, societies, or councils are sometimes called <u>DOVIAs</u> for Directors of Volunteers in Agencies. That term is used as a convenient shorthand here, nevertheless recognizing that many associations prefer other titles.

DOVIA-type associations may have unpaid as well as salaried members. The important common characteristic is a career or other serious interest in the encouragement of quality volunteering to help achieve community or organizational goals. Further, these associations are member owned and operated. The contrast is to resource organizations serving a constituency which does <u>not</u> directly govern or control the organization.

Some associations are quite highly organized with officers, by-laws, newsletters, an intensive workshop series, etc; other associations are more informal sharing groups. Most DOVIAs seem to provide a great deal in return for low membership fees; they are excellent examples of effective local self-help.

Of DOVIA popularity, there can be little doubt. This first Directory identifies well over 250 such associations with a total estimated membership of 20,000, and a mailing list outreach to many thousands more. There is good reason to believe the total number of DOVIAs in North America is in the 400 range, with total membership of 35,000 - 40,000. This combined membership probably represents about half of an estimated 80,000 careerists in the volunteer leadership field today.* By contrast, the largest single national organization involves no more than five percent of that number. Our figures indicate only about 5,000 members total in all nine national associations believed to qualify for listing here.

These calculations are necessarily approximate at this point, but certain broad conclusions are clear enough. Here in these associations, is the front-line leadership of volunteering in North America. Here is an extraordinarily rich reservoir of talent and ideas. And finally, here collectively is a large representative voice reflecting the needs and wishes of our field, for guidance within the field and advocacy outside it, with legislatures, other professional associations, the profit sector, universities, etc. In all, there is immense potential for networking, cooperation, collaboration, mutual support, and advocacy.

But, alas, DOVIAs have been insufficiently well-identified for fruitful communication among themselves and with the field at large. To my knowledge, no national DOVIA Directory has ever been seriously attempted. One reason is the informality of some groups, whose only address may be the chairperson's or president's, and that changing every year or so. Still, the effort seemed well worthwhile. I therefore attempted a first national survey between January and August 1983, then arranged this printing of results. Outside financial support for the work totalled \$200 to which I added my own personal financial resources.

The search procedure consisted of:

1) Combing my own address list of 7,000 for addresses and leads.

- 2) Publicizing the survey and asking for cooperation at 35-40 workshops and conferences.
- 3) Asking the help of significant contacts at state or province level plus about 75 volunteer resource centers and a few national organizations. I was fortunate to find such contacts in about 85% of all states and provinces.

Overall response was superb. Among other things it vindicated VAC and state offices as the experts on their geographic areas. Beyond that, it confirmed a strong tradition of helpfulness among organizations in our field. [One state with a small population and a large heart volunteered on its own to send out 3,000 survey notices.] Finally, there seemed to be an extra added measure of cooperation because people thought it high time for such a survey.

Indeed, very little <u>national</u> attention has ever been paid to local and regional DOVIAs. Little or no consideration has ever been given to their enormous potential collectively, or to their proper role in the volunteer leadership community nationally. Pretty much on their own, DOVIA-type associations have sprung up and spread out through North America. There has been no national campaign to create more of these, to cultivate and to evaluate. Typically, outside funding for such associations has been sub-microscopic

DOVIAs may be the most pervasive un-prompted phenomenon in volunteerism today, almost stubbornly spontaneous. There must be reasons, and we should begin to look for them . . .

II. A PROFILE OF NORTH AMERICAN DOVIAS

The Information Base

Two hundred entries were collated in a composite profile of associations. These were the first 200 received which clearly fit a DOVIA-type definition. Information ranged from little more than title and address, to complete survey data on about 120 associations.

Does this sample provide a representative picture of all such associations? The search procedure was reasonably comprehensive in some respects; for example, in coverage of significant state-level contacts (see Section I). In other respects, the results may only show that my personal networks are more effective in some parts of the country than in others.

A relatively large sample is less likely to be seriously biased. I was reasonably sure the list of associations was complete or nearly so, for only three states: Colorado, Michigan, and North Carolina. Over these three states the approximate proportion was one DOVIA for each half-million of population. This projects to about 500 DOVIAs for 250 million people in North America, but only if the three-state proportion of DOVIAs to population holds for every state and province. I've begun to doubt that it does. For example, this ratio would yield far more listings than we now have in Massachusetts and Texas. Yet knowledgeable people in

those states told me there simply are not that many DOVIAs in their state. Therefore, some shrinkage factor in the proportion seems appropriate and this suggests an estimate more like 350-400 for "all the DOVIAs there are". On that basis our survey includes at least half of all such associations in North America. Serious bias is not generally likely in such a large sample. Where occasionally, I believe such bias exists, I will say so.

Main characteristics are profiled in terms of rounded-off percentages. Some statistically infrequent responses are also presented because they could signal growing points in the evolution of these associations. In any case, they sometimes challenge the innovative imagination.

There is necessarily some subjectivity in categorizing and interpreting responses. Here my base of experience is working with 15-20 DOVIAs a year, and membership in six of them scattered across the continent.

Definition, Identification

In the main, these groups call themselves "Associations" (40%), "DOVIAs" or "DOVS" (25%), "Councils" (20%) or "Societies" (12%); the latter title is most likely with hospital associations. Among the scattered other titles used, "Network" is most frequent but we also see "Committee", "Forum", "Assembly", "Alliance", "brown bag", "cluster", and "round table".

The associations refer to their members mainly as Directors of Volunteer Services (55%), but also as Administrators (25%) or Coordinators (20%) of volunteers. Mentioned only occasionally are such terms as managers, leaders, scholars, and (thank you, somebody) people. Not represented in our data are some other career titles that do exist, e.g., Chief of Voluntary Services (in the Veterans Administration), Community Resource Specialists or Developers (in Florida and the Northwest U.S.), Supervisors of Volunteer Services (in some social welfare systems) and occasionally, Facilitator of Volunteer Services.

Affiliation

Some people might wonder if DOVIAs have an identity of their own, beyond being a component of some other organization, such as a Volunteer Center. To be sure some DOVIA-type associations are largely subsidiary to other organizations, but many are not, and even where there is substantial dependency, DOVIAs are usually looked to for performance of distinct and important functions.

About 20% of the associations are unaffiliated, 60% have only one affiliation, and 20% have more than one affiliation. Among all DOVIA affiliations, about one—third are with Volunteer Centers, one—fourth with the American Society of Directors of Volunteer Services (ASDVS), and about 10% are with state or provincial volunteer offices. Slightly more than 5% of reported DOVIA affiliations are with the Association for Volunteer Administration (AVA) while another 5% mention United Way. The remainder constituted a widely scattered assortment, including service delivery systems, colleges, and other national associations.

Unfortunately the survey questionnaire failed to ask directly about "horizontal" affiliative relationships between one DOVIA and another. I strongly suspect this is not widespread at present, for the simple reason that most DOVIAs have scarcely been able to find each other. I do believe that inter-relations between city or

county associations and their state DOVIA are a matter of some interest in states like Nebraska, Michigan, and North Carolina.

Coverage

DOVIAs are continental in scope. Directory entries occur for all ten provinces of Canada, 45 states, several regions, a number of nation-wide associations, and the District of Columbia. The five missing states were either low population ones, places where my contacts are relatively poor, or both.

DOVIAs for only a single town or city are fairly rare (15%). About 30% cover an entire county. Another 30% are multi-county or regional, and almost 25% include an entire state or province. Finally, this directory lists nine national associations, representing only a few percent of all such associations.

Membership

About two-thirds of the associations involve members across a range of human servides and other community concerns. The other third limit membership to volunteer directors in a single service area; for example, health care or hospitals, criminal justice, education, corporations. Hospital DOVIAs dominate these specialty-oriented associations, comprising about three-quarters of them. But this is probably overestimating the true proportion. The hospital society listings are complete or nearly so. By contrast, a number of DOVIA-type associations in criminal justice and other specialty areas do exist; I know this, but was unable to locate them for this directory.

Excepting national associations, the average association membership is about 70. But this figure by itself could be misleading. The vast majority of associations (85%) have 100 members or fewer. Indeed, about half of the DOVIAs have fewer than 30-35 members. The average is raised to 70 by a relatively small set of super-large DOVIAs (15%) averaging 200-250 members each. In any case, the range in DOVIA size is huge, from fewer than 10 members to more than 500!

The reach of DOVIAs via their mailing lists averages about a third more than their membership, or about 100 per DOVIA. Again, the range is huge from no mailing list reported to 1500 for a single association.

The nine national associations listed here range from about 100 to 2000 members each,* averaging 500-550, and totalling nearly 5,000 members. This membership overlaps among national organizations and between them and more local DOVIAs. The exact degree of overlap is unknown. My own experience suggests it is relatively small, except in specialty-oriented associations, where a person is more likely to belong both to the national and its local affiliate.

Legal Status

Slightly more than one-third of the associations are incorporated; all describe themselves as "non-profit". The unincorporated two-thirds quite often stress their informality and say they want to keep it that way. Some other associations benefit from the corporate status of a sponsor or national affiliate, and/or they mention plans for incorporating.

Budget, Dues (For all associations except national ones)

These are low-budget operations; they specialize in doing more with less. Revenues mainly come from dues, workshop fees, and occasional donations. No DOVIA mentioned having a grant or regular budget allocated to it from some sponsor organization. I know for sure of only one DOVIA which seriously considered a grant application, though I suspect other DOVIAs have done so.

Miniscule budgets are made up for by a great deal of in-kind volunteer service from members and sometimes also from sponsoring organizations such as volunteer centers.

The range in dues is spectacular, from zero to \$100 a year (in only one case, as a corporate membership). The average is between five and ten dollars a year, a little closer to ten than to five. The breakout is: no dues (23%), \$1-\$5 (22%), \$6-\$10 (30%), \$11-\$15 (12%), \$20 (6%), \$25 (5%), and \$30 or more (2%).

About 15% of the associations have a membership fee scale, with different fees for students, agencies, etc.

Purpose

Strong common threads run through the purpose and goal statements of these associations.

- --Virtually all of them include in their purposes:
 - 1) Networking, information exchange, sharing, communication, linkage among their members. About 15% of DOVIAs added a "support group" variation on this theme.
 - Training and education to upgrade knowledge and skills of Volunteer Directors.
- --Half or more of the associations share these two goal-themes.
 - 1) To promote professionalism. About 10% of responses also alluded to development of professional standards.
 - 2) To promote volunteerism and volunteer programs; to upgrade the dignity and status of volunteers.
- --About 30% of DOVIAs speak in one way or another of minimizing duplication, encouraging coordination and joint operations in areas such as volunteer recruitment, placement, training, recognition, and public relations.
- --About 5% of the DOVIAs mention each of the following: resource development, problem solving, link to outside, legislative review and advocacy, and either establishing or being advisor to a Volunteer Bureau.
- --Stated as DOVIA purpose only occasionally (less than 5%) were challenges such as job opportunities, creative programming, certification, keeping up with national trends, and recognition for Directors of Volunteer Services. My own experience is that while job opportunity information is not an official purpose of many DOVIAs, it is an important unofficial benefit.

Activities and Events

Virtually every association:

- 1) has regular meetings. DOVIAs generally meet quite frequently. Forty percent meet monthly, though sometimes not in summer. Others meet every other month (30%); quarterly (20%); twice yearly (5%) or annually (5%). My impression is that a great deal of networking is expected to occur at these meetings, and usually does.
- 2) has workshops, conferences, educational meetings. Frequencies vary from once a year to monthly (usually in conjunction with the regular monthly meeting). The average number of workshops is about 3-4 times a year, and the clear majority of trainers are DOVIA members or other local talent.
- 3) sponsors or co-sponsors volunteer recognition events during national volunteer week and/or at other times during the year.

About half of the associations publish their own newsletter as an information and networking vehicle. Frequency of publication is monthly (25%), every other month (30%), quarterly (30%) or only once or twice a year (15%). I regularly receive about ten of these newsletters and find them generally of excellent quality, often comparing favorably with national newsletters.

Some DOVIAs without their own newsletter, have news coverage in a column or section of an affiliated or sponsoring organization, for example, the local volunteer center.

DOVIAs do very little other publishing beyond newsletters. There is mention of organizational materials, such as brochures, flyers, meeting notices and minutes. About 5% of the associations report publishing a membership directory. Another 5% publish a handbook or brochure describing volunteer opportunities.

The range and intensity of DOVIA activities becomes even more impressive when one realizes that these are in the main all-volunteer operations, on the part of people who are very busy elsewhere. Some DOVIAs do receive support services from the local VAC, United Way or other affiliate, but even here, volunteers probably provide much of this support service.

So far as I am aware, no associations (except national ones) directly employ any paid staff. Only a very few DOVIAs have even talked about this.

III. THE DIRECTORY

Addresses and Network Information for Each Association

Listings are alphabetically by state or province, followed by regional and national entries.

Specialty-oriented associations are indicated in parentheses (e.g., "health care") if not obvious from their title. All other associations span a variety of service or involvement areas.

A few entries do not clearly fit our definition of DOVIA. When in doubt, I tended to leave the decision on belongingness to the organization concerned. Moreover, I felt organizations financially supporting this survey deserved representation here as potential network partners.

DOVIA addresses tend to change frequently; permanent addresses are rare. Therefore, backup addresses are given where known along with this caution: <u>Use of this directory in 1985 or later is at grave risk of innacuracy</u>. A new directory is planned for 1985.

Addresses for ASDVS affiliated groups are sometimes omitted in deference to ASDVS' policy of discouraging their use in survey work (my two written inquiries to ASDVS regarding the present survey have not been responded to). Where address and other information on hospital DOVIAs clearly and voluntarily originated in sources other than ASDVS national office, that information is presented here.

Each entry contains the following information, mainly for its potential in productive networking (See Sec. IV).

(1) Affiliation, if any

ASDVS = American Society of Directors of Volunteer Services

AVA = Association for Volunteer Administration

NAVCJ = National Association on Volunteers in Criminal Justice

S/PO = State or Provincial Office of Volunteerism

UN = United Way; VC = Volunteer Center

No entry means unaffiliated as far as I know.

- (2) Note that the association has a newsletter and how frequently it is published. No entry means either they have said they don't have a newsletter or we have no information on this point.
- (3) "Like to Learn", "Successes to Share". Where available, full responses are given to the following survey questions.

What would your association most like to learn from or about other associations such as yours?

What successes or information would you most like to share with other associations?

There are 267 entries in the Directory. Of these, I feel that 230-240 fit our broad definition of DOVIA with reasonably high probability. The other entries might also fit in some fashion, but there is less certainty about this.

IV. NETWORKS AND OTHER RESOURCES

Networking Within Associations

Virtually every DOVIA sees its own membership as a primary resource. There is a strong commitment to the importance of what people can learn from one another, described variously as "sharing", "exchange", "networking".

In successful networks, as in successful volunteer programs, it helps if the heart is in the right place. But the head has to be in the right place, too; that is, there are definitely right ways to network, and wrong ways.

Two how-to-do-it references are described further in the enclosed Yellowfire Press Catalog.

- 1. The Bridge: A Guide for Networkers by Ivan Scheier and Susan Dryovage, 1981 with late 1983 supplement, about 50 pages. Note especially here the newly developed "Central Network Pool" method. This model is being tried out by at least one DOVIA.
- 2. The Networking Game by Patricia Wagner and Leif Smith, 1982, 50 pages, and full of practical pointers on productive approaches to networking.

Networking Between Associations

Associations seem eager to be in touch with one another, compare notes, exchange ideas and information on what works and what doesn't work. For example, these two general themes were prominent in survey responses:

- We'd like to learn more about similar (successful) models, programs, ideas, activities, especially innovative ones, which other associations have.
 - 2) We'd like to learn more about how other associations are organized, their structure, by-laws, goals, membership fees, etc.

Beyond this, about a quarter of the DOVIAs in this survey explicitly said they'd like to learn how to strengthen networks with other associations. DOVIAs themselves contributed some of the following suggestions for improved networking.

- Exchange newsletters.
- 2. Before any travel, your members might check the directory for associations along their way, then write ahead for permission to attend one of their meetings or have a chat with some of their leadership people. The results could make an interesting report for the next meeting after the return of the traveler.
- 3. This directory might help you identify relatively nearby DOVIAs. Joint meetings might then prove feasible, for the entire membership, or at least certain committees or just whoever wanted to carpool to the meeting place.
- 4. Ask conveners of regional, state, provincial or national conferences to set aside time for DOVIA exchange meetings.

The above three kinds of direct contact between associations might well spice member interest—and greater interest on the part of members was a frequent issue among the associations surveyed.

5. Perhaps some other associations and you share an affiliation--state, provincial, or national. Perhaps, too, specific suggestions could be made to the affiliating organizations on ways it could facilitate more sharing among its affiliates.

If you are unaffiliated now, or wish to consider additional affiliations, check out what national associations (Sec. III), state DOVIAs, state offices or volunteer centers may have to offer.

6. Review the "successes to share" entries in Section III, then contact the associations which have information of potential value to your association. Along with your request, I suggest you offer something which helps with one of their "like to learns" or in some other way makes it "trade not aid", if you can. Even so, don't expect a response to every inquiry. Associations with popular successes could eventually get overwhelmed with requests.

Rather than sketch in here what others have already done solidly--

- 1. A fine handy guide to resource organizations, books, periodicals, educational opportunities, etc. is <u>Finding Your Way Through the Maze of Volunteer Management</u> by Sue Vineyard. See the Yellowfire Press Catalog, enclosed.
- 2. The Community Resource Tie Line provides the same sort of resource-location service at a positively encyclopedic level. Edited by Harriet Kipps and regularly updated, it's available on a 60 day free trial from Gale Research Company. See enclosed brochure.
- 3. The Journal of Volunteer Administration, under the editorship of Susan Ellis, is recommended for its overall quality, and also specifically for its section on abstracts. This section, plus similar coverage in a predecessor journal could form the core of a ready reference library for your association.

A separate notice about <u>The Journal of Volunteer Administration</u> is planned for the present directory. If you do not find this notice, you can inquire about the journal from the Association for Volunteer Administration, P.O. Box 4584, Boulder, CO 80306.

Other resources might be developed especially to fill the needs of DOVIA-type associations. Section VI has more on these possibilities.

V. ISSUES AND OPPORTUNITIES

The broad question is: how can DOVIAs best relate to the rest of the volunteer leadership community? This includes resource organizations such as volunteer

centers, state or provincial offices of volunteerism, and organizations such as the National Center for Citizen Involvement (NCCI). It also includes the national associations with which DOVIAs may be affiliated: ASDVS, AVA, NAVCJ, etc.

First of all, are DOVIAs destined to be primarily absorbers of services $\frac{\text{from}}{\text{that}}$ the rest of the volunteers leadership community, providers of services $\frac{\text{to}}{\text{that}}$ community, or both on a roughly equal basis?

On the one side some local volunteer centers seem to consider the local association mainly as a client or subsidiary to which they provide administrative and other help, getting little or nothing back in return. National associations too, seem often to perceive themselves largely as providing support to their local affiliates, rather than receiving support from them (except for fees).

Yet there are instances of flow in the other direction; for example local DOVIAs who act as valued advisers to the local Volunteer Bureau, do the heavy work of putting on workshops it would otherwise have to arrange alone and, indeed, may have founded the Bureau in the first place. Moreover, in at least two instances I know of, after a state office of volunteerism went under, a state DOVIA picked up much of the slack. This Directory confirms that DOVIAs, as organizations, are capable of providing, and generating vital services, such as recognition, education and training, etc., etc. (see Section II). Many of these services overlap those which resource organizations are struggling to provide with limited resources. I therefore hope resource organizations or national associations who now see DOVIAs primarily as absorbers of services, will take a leaf from the book of the creative interviewer of volunteers and try to see people and organizations more from the perspective of potential than of problem. I believe that when you begin to see it that way, it's more likely to happen that way. And I believe our field needs to give DOVIAs more of a chance to give what they can, as they receive what they must.

The above is but one aspect of a larger issue: Are DOVIAs to relate to the rest of the field in a manner which is 1) Dependent, 2) Independent, or 3) Interdependent (harmonious rather than adversarial)? All options and shadings between exist today. My preferred option has already been stated. Though I certainly don't underestimate the difficulties of curing organizational dependency, I think it can be done, and that the attitude of the parent organization can be a big plus in that enterprise—or an equally big minus.

One outcome of positive inter-dependency could be a national coalition of DOVIAs. If DOVIAs decide to coordinate more closely with one another, and succeed in doing so, they will create a coherent voice of volunteer leadership, the like of which we have never seen before. On our earlier estimates, DOVIA membership collectively includes about half of all careerists in our field, twenty times more than the largest single national association.

Here is the most significant sounding board we have ever had for the guidance of national leadership organizations and individuals--state and provincial as well. Needs assessment can tap into a large active body of grass roots opinion and information.

Here, too, is a vastly strengthened, accessible constituency for advocacy on issues affecting volunteers and their leadership. I dream of petitions with forty thousand signatures accompanied by blizzards of telegrams from across North America, Canada, or the U.S.

It could happen if associations want it to, but DOVIAs have other options, too, and some of them may prove more attractive. (1) Remain separate and independent. (2) Continue one present emphasis on combining primarily with parallel local resource centers (such as VACs) rather than with other non-local DOVIAs. (3) Make their primary affiliations "vertically", "upward" with state, provincial, or national organizations rather than with each other.

Of course, there is no reason an association couldn't do the second two things as well as explore stronger coordination with other DOVIAs. But energies and resources are limited. Priorities must be placed somewhere, also primary loyalties.

Thus, about a third of the associations are organized by service area such as health care, criminal justice, education, corporations, army community service, etc. These are the DOVIAs which tend to affiliate vertically (par. 3 above) with state and national organizations in their service area. No doubt this is because the allegiance to their area of service is at least as strong as their allegiance to volunteerism in general. Here then is a long question? Will specialty-oriented DOVIAs, or significant proportions of their membership have enough time, interest and energy to move solidly with general volunteerism as well as with their specialty area? There is some evidence that the answer is often "yes", but research is needed to determine "how often", and unless the answer is "very often", I suspect we will never achieve a truly national constituency for volunteerism as a professional enterprise.

I am one who believes such a constituency can be consolidated in the next few years--if DOVIAs want to do so. The issue then is whether this voice would be listened to and properly capitalized on by national and North American leadership of volunteerism both organizational and individual.

I know of many who would welcome a stronger version of a voice they have always tried to heed. I know of others who could be enormously threatened by this development and would denigrate or deter it. These are the organizations and individuals who see their leadership function largely as telling "less knowledgeable" people in the front lines what their goals should be--even sometimes what their needs are. Yet I have never figured out how one can lead without listening--carefully.

VI. WHERE DO WE GO FROM HERE? (Or should we just stay where we are?)

I hope this directory has helped in at least some of these ways:

- --The sheer knowledge that there are so many other associations, and wherethey are.
- --Summary coverage of what DOVIA goals are, and what DOVIAs are doing.
- --An assist toward increased networking with other associations, should you choose to do so.
- -- Raising of some issues for further consideration.

Is this enough, or is there more we might do? I realize many if not most of you may be perfectly content with the services you now receive from your national affiliate, sponsor, etc. Fine, but if not, here are some possibilities I see. What do you think, and what other possibilities do you see?

- A. Some associations are concerned about funding sources, and so far this publication hasn't dealt with that at all. Perhaps, then, you might wish to follow up on the Yellowfire Shared Benefit Plan, enclosed. The plan represents a kind of do-it-yourself funding which, though modest, appears consistent with DOVIA spirit and substance.
- B. DOVIA addresses tend to change rapidly. Using this directory in 1985 is dangerous to your accuracy. So, would you like to see a 1985 directory? It would be published about a year from now, in autumn, 1984. Coverage would parallel this year's, though probably somewhat more extensive and relevant because of your feedback on this directory, and all I've learned from this year's mistakes.

If you do want to see a 1985 directory:

- 1. Please, fill out the 1985 form enclosed with this packet. This guarantees representation of your information and your views, in next year's publication.
- 2. I prepared this year's directory for the best reason in the world: I enjoyed it and felt it was an important thing to do. I expect to prepare next year's directory for the same reasons. But one thing I don't want to repeat next year is loss of several hundred dollars of my own personal funds. This occurred, at my own choice, because I decided to send this first directory to every association listed, even though many did not choose to contribute financially—or couldn't afford to. But this next year, I do need a check or money order from you, if you want to receive a copy of the directory.

In summary, I hope everyone with relevant information will send in a survey form. But only those who can also send a check will receive the 1985 directory

- C. Here are some other things that might interest some of you.
 - By-mail response to your information inquiries about DOVIAs, up to several times a year, in cases where networking with other DOVIAs doesn't develop this information.
 - 2) Written information about national trainers and their specialties and their fees, in response to your requests.
 - Note: Since I travel heavily, the above two services cannot be offered on a rapid telephone callback basis. They will be by mail with at least two weeks allowed for response.
 - 3) A DOVIA manual. How to start, maintain, and strengthen a local, state, or provincial association of volunteer directors: structures, by-laws, activities and events, model programs, dues, other funding sources, how to keep membership motivated, common problems and successful ways of dealing with them, the history of DOVIAs and their promise for the

future, etc. The manual will probably be published in late summer or early Fall, 1984.
